DIRECTIONS TO THE HAYDEN CENTER

The Monsignor Hayden Center is located just outside of downtown Saint Paul at 328 West Kellogg Boulevard down the hill from the Chancery and the Cathedral at the corner of Mulberry and Kellogg Boulevards. Mulberry is two (2) short blocks east of Summit Avenue.

FROM THE NORTH

35E South to I-94 West to Marion Exit. Turn left onto Marion. Marion turns into Kellogg Blvd. Follow Kellogg Blvd. to Mulberry and turn right.

FROM THE SOUTH

35E North to Kellogg Blvd. Turn left onto Kellogg Blvd. Follow Kellogg Blvd. to Mulberry (second left turn) and turn left.

FROM THE EAST

I-94 West to Marion Exit. Turn left onto Marion. Marion turns into Kellogg Blvd. Follow Kellogg Blvd. to Mulberry and turn right.

FROM THE WEST

I-94 East to the Marion/Kellogg Blvd. Exit. Turn right onto Kellogg Blvd. Follow Kellogg Blvd. to Mulberry and turn right.
